



## **RULES AND REGULATIONS**

**Please Read and abide by all Rules & Regulations!**

### **PREMIUM LIST**

No changes shall be made in these rules, or the Premium List as published herein except permitted by the State Department of Agriculture. The Kankakee County Fair is being run according to the instructions of the Department of Agriculture of the State of Illinois. All correspondence shall be mailed to the Kankakee County Fair, Office Manager, P.O. Box 714, Kankakee, IL 60901.

### **EXHIBITS AND PREMIUMS**

Exhibits and Livestock are required to be in place for exhibition on the fairgrounds in accordance with state rules (Sections 260.50 and 260.55). Kankakee County Fair Junior and Open Classes are open to the world and entry must be posted with the Kankakee County Fair Office. Kankakee County 4-H Classes are limited to Kankakee County and must be entered at the University of Illinois Extension-Kankakee Unit Office.

### **REGISTRATION PAPERS**

Registration Papers are required for all purebred livestock (Section 260.80). Registration Papers must be made readily available for inspection by Fair Directors or Department Superintendent in charge and remain in exhibitors' possession for duration of the fair. In case of grade animals, the breed's name shall be that of the sire. Herd, Flock and Group Classes are defined in individual departments. Photocopies of registration papers are not acceptable.

### **HEALTH REQUIREMENTS**

All exhibitors of livestock are required to abide by the current State of Illinois Health Requirements and documents must be readily available upon request by Fair Directors, Show Superintendents, or official Veterinarian of the Fair. Out of State Livestock must have entry permit from the Illinois Dept. of Ag.

### **PREMIUMS**

No premium will be paid without a Social Security Number. All junior exhibitors must have date of birth on entry form to be paid a premium. Payment of premiums by check at the Fair Office will be on Sunday 1:00 p.m. until 5:00 p.m. **PICK UP YOUR PREMIUMS** no later than the final evening of the fair!! The Treasurer or Secretary of the Fair Association reserves the right to cancel or stop payment on any checks issued by the Kankakee County Fair if not cashed within 60 Days from the date of issue. All Premiums not picked up at Fair Office will be mailed by Friday following Fair.

### **LIVESTOCK AND EXHIBITS**

All livestock must be registered with the Kankakee County Fair Office by the advertised entry deadline date and a livestock fee must be paid accordingly. All 4-H Livestock not entered in Kankakee County Fair Junior or Open classes must pay a one-time stall or pen fee for each animal entered. The deadline date will be the fairs posted entry deadline date. There will be no stall or pen available for livestock not registered with the fair office by the fair's posted entry deadline date. No livestock will be allowed until Tuesday, day before Fair. All 4-H livestock and/or exhibits and 4-H superintendents are required to enforce and abide by all rules and regulations printed in this book.



## **VEHICLE STICKERS**

Vehicle stickers for Livestock Exhibitor's and Concessionaires may be obtained at the Fair Office. Limit one (1) vehicle sticker per family allotted when entry is posted at the Fair Office. Only permitted vehicles will be allowed in the midway and livestock areas to deliver feed supplies. These permitted vehicles must be parked in designated areas which are clearly posted. All permitted vehicles and trailers must revert to general parking or posted exhibitor parking areas by 10:00 a.m. each day of the fair. Any vehicle and or trailer illegally parked will be towed at owner's expense. This rule will be strictly enforced as ordered by the State Fire Marshall!

## **CAMPING PERMITS**

Camping permits may be obtained at the Fair Office. All campers are required to be parked within designated area and permit must be displayed accordingly. All vehicles located in camping areas must have "East or West Camping Vehicle Permit" or "Official Parking" permits in the window. All others will be towed at owner's expense.

## **NSF CHECK POLICY**

Checks returned from your financial institution for any reason will cost the writer a \$25.00 fee plus any collection fee incurred along with the check amount. Failure to redeem these items by September 30 of the year the check was written will constitute disqualification for entry into future fair exhibits. A list of all violators will be sent to the Illinois Department of Agriculture for posting.

## **PREMISE IDENTIFICATION & ANIMAL ID**

The Illinois Department of Agriculture offers competitors the choice to register for a premise I.D. for the location where animals are kept. Premises registration is critical to protecting Illinois' livestock industry as it helps animal health officials minimize trace back times in the event of an animal disease outbreak. The following species are offered a premises ID: Cattle, Swine, Sheep, Chickens, Ducks, Geese, Rabbits, Llamas, Alpacas, Horses, Mules, Deer/Elk, Turkeys, Pheasants, Quail, Guineas, Ratites (Ostriches, Emus), and Goats. A form is also in the front of this premium book for your convenience. This is on a voluntary basis only currently.

## **PREMIUM WAIVER STATEMENT**

The Department of Agriculture shall use its best efforts to secure sufficient appropriations to fund premiums in any year for which the General Assembly of the State of Illinois fails to make an appropriation sufficient to pay such premiums, amounts may not be accurately reflected in the book.



## GENERAL RULES

1. The Kankakee County Fair & Exposition, Inc. reserves, to its Board of Directors, the final and absolute right to interpret these rules and regulations and to settle arbitrarily and determine all matters, questions, and differences in regard thereto, or otherwise arising out of, or connected with or incident to the Fair.
2. While the Fair Association will give adequate police protection and take such precautionary measures as are consistent in the operation of the Fair, the Fair Board, and the Kankakee County Fair & Exposition, Inc., will not be responsible to any person or individual, corporation or association for any loss by either fire, theft, or personal injury sustained by anyone through the negligence of any person, group of persons, exhibits or exhibitors, including electrical voltage surges or drops.
3. The Directors of the Kankakee County Fair and Exposition, Inc. reserve the right to cancel the Fair and to withdraw all premiums offered should unforeseen circumstances occur which, in the judgment of the Directors would make it advisable to do so, and all premiums offered, and contracts made shall be null and void.
4. All livestock and/or articles entered will be at all times subject to the control of the Board of Directors. Every precaution will be taken to prevent loss and accidents, yet the Fair Association will not be responsible should any occur.
5. No alcoholic beverages are allowed around the fairgrounds that were not purchased from the fairgrounds except for in one's own camper in rented/permitted campground site. Failure to comply with this rule may result in the individuals being asked to leave the fairgrounds immediately; if an exhibitor with his or her exhibits, forfeiting his or her premium awards and possibly being barred from future exhibition.
6. Transfer of tickets from one person to another or selling of tickets from one person to another is against the rules of the fair and any violation of this rule will result as a forfeiture of all rights and privileges during the fair. Legal prosecution is possible.
7. Any correspondence with the Fair's office machinery or office supplies must be done through the Fair Office Manager.
8. All contracts (judges, announcers, associated personnel) and or reimbursable expenses must have previous approval by the Board of Directors and a signed approval by the Fair's Treasurer.
9. Entries: All entries must be in the office of the Kankakee County Fair & Exposition, Inc., Kankakee, Illinois on or before Saturday, July 23, 2022. Unless mailed, all entries must be placed at the Fair Office. All Entries must be postmarked on or before July 23, 2022. No entries will be accepted unless all fees accompany same; entries with class numbers only will not be accepted. **NO LATE ENTRIES WILL BE ACCEPTED!** To help both the exhibitor and association, mail all entries early to Kankakee County Fair, P.O. Box 714, Kankakee, IL 60901. Entry blanks are in the front of this book. Entry deadline is July 23, 2022.
10. By Board action, all exhibitors (exception – those with Lifetime Pass) must purchase an exhibitor's pass with a bonafied entry. All "no show" entries will void exhibitor's pass. Exhibitor passes are only available to those placing a bonafied entry, all others must purchase a season pass or pay daily admission at gate.
11. No fees will be refunded at any time.
12. Do not bring exhibit at time of making entries to office. Exhibits are due at the fair grounds at the time posted in the department listings.
13. Exhibitors shall check all exhibits in with the Department Superintendents in charge upon arrival. Be sure that your exhibits are properly marked.



## GENERAL RULES (continued)

14. All entries, unless stated otherwise in breed classifications, must be made in the name of the owner, and all made or manufactured articles must be entered by the maker. All articles and animals entered must have been owned at least 30 days before the Fair opens (unless otherwise stated in breed classifications) and be able to show ownership accordingly.
15. Exhibitors may enter as many exhibits as desired; however, only two premiums will be awarded to any individual in any one lot. Where there is no competition in stock or article, only first premium shall be awarded. Thus, only when one entry is made in a lot, it will automatically qualify for the first premium unless the Judge deems the entry not worthy.
16. A display tag will be furnished by the Fair Office for articles entered under Department #110-#119 and #210-#215. Display tag must remain attached to said article during the fair. Exhibitor's claim check portion or tag must be presented to the Superintendent in charge of the Department at close of fair to receive said article.
17. Neither the Office nor any Officer of the Fair shall disclose to competitors or any other person what entries have been made, nor shall any other person, other than the Office and Officer of the Fair be allowed to know what other entries have been made before entries close.
18. Removal of an exhibit or any part of an exhibit before stated release time is prohibited without prior approval of the Fair Office Manager. Exhibitor must have a signed permission slip of the attending veterinarian, or a permission slip signed by the Fair Office Manager and a copy presented to the show superintendent. Anyone leaving before release time without permission will be barred from future exhibitions and all premiums will be forfeited. See EXHIBITS AND PREMIUMS. Exception – locker plant trucks hauling animals sold for slaughter on 4-H Auction.
19. No exhibit (animal or article) shall be judged, or premium paid on such awards unless such exhibit has been properly entered in the specific class. Judges and Superintendents do not add entries to the Judges List. Any discrepancies must be settled at the Fair Manager's Office. Should any doubt arise in the mind of the judges as to any exhibit (animal or article) being entered in the wrong class, the same shall be referred to the superintendent, and if he/she is unable to decide, he shall refer it to the Grievance Committee.
20. Protest: An exhibitor lodging a protest must deposit \$50.00 with the Fair Office Manager, which sum will be forfeited to the Kankakee County Fair & Exposition, Inc., if the protest is not sustained. All protest must be in writing, signed by the protester, and must be lodged within two (2) hours after incident. The protest will be presented to the Grievance Committee appointed by the President of the Fair Board of Directors. The decision of the Grievance Committee will be final.
21. Judging: All competing animals shall be exhibited and paraded at the discretion of the superintendent and any exhibitor failing to comply with this rule will forfeit any premiums awarded to his exhibit. Any person attempting to interfere with the judge, or who shall tear off a ribbon in the presence of a judge, shall forfeit all premiums and be barred from further exhibition.
22. Ribbons: Blue – 1<sup>st</sup>, Red – 2<sup>nd</sup>, White – 3<sup>rd</sup>, Royal Purple Rosettes for Champions, Lavender Rosettes for Reserve Champions, unless designated otherwise by show.
23. No animals will be allowed on the premises or in the barns occupying space unless they are entered and have paid appropriate fees to the Kankakee County Fair office, therefore all requests should be listed in the space on the entry blanks and calculated fees shall be paid accordingly.



## GENERAL RULES (continued)

24. Stalls: All stalls/pens will be assigned by superintendents of the departments according to report generated by the fair office.
25. Livestock: All livestock must be stalled and/or penned in the parking lots. No animal will be allowed to run at large on the grounds. Failure to comply with this rule may result in the individual(s) being asked to leave immediately with their exhibits, forfeiting premiums and possibly being barred from future exhibition.
26. Equine: All equine must enter through the West Gate. Equine stalled in horse/pony barn must be tied in stalls. Equine for one day shows must be tied/penned at trailer and trailer must be parked within designated (posted) area.
27. Equine: All equine is restricted to their show ring for riding and exercising. Absolutely no equine is allowed on asphalted areas. Failure to comply will constitute immediate removal from grounds.
28. Beef: All beef animals are to remain in their barns until 8:00 p.m. Beef may go to designated tie-out area after 8:00 p.m. Wednesday through Saturday. All beef must remain in their designated barns until scheduled release time on Sunday. No wood chip bedding. Exhibitor to provide their own straw or wood shavings for bedding. All bags and twine to be properly disposed of by exhibitor. Exhibitor must rake their area 3' from all walls when released or risk being barred from future exhibition.
29. Exhibitors: All exhibitors must maintain neat and clean exhibits during the duration of the Fair. Aisle ways between stalls and pens must be kept clean of feed, baled hay/straw, bedding, and equipment at all times. All stalls must be cleaned prior to leaving the Kankakee County Fair. Failure to comply with this rule will result in premiums being forfeited, and the exhibitor barred from further exhibition at this Fair. The appearance of exhibits will be determined by a committee from the Fair Board of Directors and Fair Superintendents.
30. Dumpsters: Exhibitors must use the dumpsters stationed at each barn (or designated area) for manure and bedding. Do Not use these dumpsters for general trash. Do Not use garbage barrels in barns for animal waste and/or bedding. These barrels are for general trash only and are there as a common courtesy for fair goers and not for animal waste or bedding. Cooperation from all exhibitors is mandatory.
31. Exhibitors of livestock must furnish their own buckets, feed, and bedding unless stated otherwise in breed classifications. No water tanks allowed. All electric fans must be covered with hardware cloth on both sides of cages. No wood chips!!
32. Exhibitor parking is designated and posted: All livestock trailers on the East side of the facility must park in the East Campgrounds (along the furthest east fence facing 45/52). All livestock on the West side must park all trucks and trailers in Lot 6 (north of the north gate). Only Beef Cattle trailers (single row) are allowed around the Beef tie-out area. Parking on the Slag Area on the West Side is prohibited unless you are an exhibitor entered in a one-day show; (Equine Gaming Shows). All violators will be towed without warning at the vehicle owner's expense. All vehicles with a valid Exhibitor Parking Permit must revert to general parking by 10:00 a.m. every day of the fair.
33. Superintendents: All Fair Superintendents will have the arrangement and supervision of the animals or articles on exhibition in their departments and are held responsible to the Kankakee County Fair Board of Directors for the management of their departments. Kankakee County 4-H Superintendents shall report to Fair Superintendents.



## GENERAL RULES (continued)

34. Superintendents will be responsible for notification to the exhibitors when animal/articles will be shown.
35. Superintendents will afford the judges every facility for examination and will affix the premiums under the direction of the judges and/or see that the judging books are properly kept and signed by respective judge. Superintendents shall return the judge's books to the Fair Office as soon as the judging is completed. Payment of premiums can be authorized only upon entries contained therein.
36. Superintendents will remain in their respective departments to allow exhibitors to pick up their animals/articles on Sunday until such time that all animals or articles are removed.
37. Superintendents will perform other duties pursuant to the position if requested by the Board of Directors, such as completing press releases, etc.
38. Commercial Exhibits: Commercial exhibit space can be contracted from the Contract Chairman if space is available. Space for all other types of exhibits is in modern, lighted exhibit halls or can be obtained outside with exhibitor furnishing tent. Under no circumstances shall any person be allowed to sell goods of any description unless they bought privilege space. Violators will be prosecuted. All commercial exhibitors must abide by the rules of the Association and terms of licenses. Failure to do so shall subject them to forfeiture of their privilege and exclusion from the grounds without reimbursement.
39. Unauthorized Vehicles/Items: Including but not limited to bicycles, skateboards, golf carts, ATV's, rollerblades, pellet/dart guns, look-a-like handguns (toys), switch blades, fireworks, smoke bombs, snaps, et. only wheelchairs and mobility carts are recognized as authorized handicap transportation. If in doubt, ask a Kankakee County Fair Board Director. If you need assistance, please call the Fair Office at 815-932-6714.
40. PETS: Pets are only allowed in the Campgrounds at owner's rented camp location. Pets are not allowed in any other area of Fairgrounds. All pets must be always on a leash and current health records are mandatory to have upon request.
41. Handicap assistant animals are only allowed with full handicap assistance harness on the fairgrounds. No exceptions!
42. Signs/Signage: No posting of any sign or signs within or outside fairgrounds property unless authorized by Kankakee County Fair Board.
43. Passes: By accepting or purchasing passes, you agree to abide by all rules and regulations in this book.

### **COURTESY AND COOPERATION:**

Please keep in mind that the officers, superintendents, and committees of the Kankakee County Fair work without compensation and to say the least it is a thankless job. It is justly due them that you at least try to cooperate in a respectful manner. This will make the Kankakee County Fair more pleasant for all concerned. The Kankakee County Sheriff's Deputies are here throughout the fair for your protection. Please ask them or a Kankakee County Fair Board Director if you have any altercations.

### **2022 Exhibition Livestock Health Requirements**

#### **County Fairs**

#### **GENERAL REQUIREMENTS**

**These Exhibition Health Requirements apply to all livestock present at the fair including those animals that are not entered in competitive events.**

1. Exhibitors are required to familiarize themselves with all rules applicable to their exhibits.

All out-of-state animals shall require an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782- 4944. Permits may also be obtained online at: <http://www.agr.state.il.us/AnimalHW/animalregistry/login.php>

2. All animals, except as noted, shall be accompanied by a Certificate of Veterinary Inspection (CVI) which shows that the animal meets all health requirements for the State of Illinois. CVI's shall be made available to Bureau of Animal Health Personnel on request.

CVI means a legible record made on an official form from the state of origin which has been issued, signed, and dated by an accredited veterinarian and which shows the name and address of the animal's owner or exhibitor and the results of all required tests or vaccinations. A CVI shall list only one animal identification per line; shall be presented on the form on which it was initially issued; and shall not be corrected, changed, or altered in any manner.

3. All animals shall be officially identified. The animal(s) official identification shall be recorded on the CVI.
4. If animals are from tuberculosis accredited, brucellosis certified, pseudorabies qualified, or brucellosis validated herds, the identifying herd number(s) along with the date of the last herd test(s) shall appear on the CVI.
5. CVI for out-of-state livestock shall be void thirty (30) days after issuance.
6. CVI for Illinois-origin livestock shall be void ninety (90) days after issuance.
7. All livestock shall be subject to examination upon entry to any Illinois fair or exhibition. Any animal showing evidence of infectious, contagious, or communicable diseases shall be immediately withdrawn and held in quarantine at the owner's risk and expense until properly treated and recovered, or until the animal is released to return to the owner's premise. Any livestock infected with scabies, mange, active lesions of ringworm, sore mouth, or multiple warts which are easily visible without close examination shall not be permitted to exhibit and are subject to quarantine or removal from the fairgrounds. Sheep and goats with caseous lymphadenitis as evidenced by draining abscesses shall not be exhibited and are subject to immediate quarantine or removal from the fairgrounds.
8. Illinois Department of Agriculture personnel or designee may collect blood, tissue, milk, or urine samples from any animal being exhibited and/or raced at any Illinois fair to test for the presence of illegal drugs or banned substances. New examination techniques, such as ultrasound, may also be used at any time while the animals are on the grounds of any Illinois fair or exhibit. The Illinois Department of Agriculture or designee may collect urine, blood, tissue, or other test samples from exhibition animals at the time of slaughter.
9. All exhibitors of animals at any Illinois fair or exhibition shall comply with the provisions of the Illinois Humane Care for Animals Act. If violations are observed, the animals(s) will be excused from exhibition and ordered removed from the grounds with all awards being forfeited.



Any practice or deviation from normal, accepted care, including physical, medical, or mechanical application, shall constitute a violation of show rules and may result in the animal(s) disqualification and removal from the fairgrounds.

10. Any Illinois cattle, bison, Cervidae or goats being exhibited in non-accredited free states must be isolated from the remainder of the herd/flock upon return to Illinois and retested for tuberculosis 60-120 days post-entry.

## **CATTLE**

### **Identification**

Individual identification of each animal shall be either a fully healed and legible tattoo, approved official ear tag, registration number (can only be used if the tattoo is recorded on the registration certificate or for breeds where pictures are acceptable), or individual brands, if brand is recorded on the registration certificate.

### **Illinois Cattle**

#### **Brucellosis**

Illinois is a Bovine Brucellosis Class-Free State. Brucellosis testing is not required for Illinois cattle.

#### **Tuberculosis**

Illinois is an Accredited Tuberculosis- Free State. Tuberculin testing is not required for Illinois cattle.

**Please note: Illinois calves under 6 months of age, and Illinois steers are not required to have a Certificate of Veterinary Inspection.**

### **Out-of-State-Cattle**

All out-of-state cattle are to be accompanied by an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online at:

#### **Brucellosis**

1. Female cattle six (6) months of age and older and bulls eighteen (18) months of age and older shall be negative to an official test for brucellosis within thirty (30) days prior to entry, unless exempt by one (1) of the following:
  - a. Originate directly from a certified brucellosis-free herd.
  - b. Official vaccinates of dairy breeds under twenty (20) months of age or official vaccinates of beef breeds under twenty-four (24) months of age.
  - c. Animal originated from a "Class Free" state (if entire state is so classified)
  - d. Steers and spayed heifers are not required to be tested for brucellosis.
2. The negative brucellosis test shall be conducted at a state or federal laboratory within 30 days prior to exhibition.

#### **Tuberculosis**

1. Accredited Tuberculosis Free States. No tuberculin test required. All cattle, including steers, originating from an Accredited Tuberculosis Free State, may enter Illinois for exhibition when accompanied by a CVI issued by an accredited veterinarian within 30 days.
2. Non-Accredited Tuberculosis Free Areas or States (Not TB Free)
  - a. Cattle must originate from a herd where a complete herd test was conducted within the past year.
  - b. The individual animals entering Illinois must be negative to an additional tuberculin test conducted within 30 days prior to exhibition.



- c. Cattle that enter Illinois for exhibition and remain in Illinois (animal does not return to the state of origin within 30 days) must be isolated and retested for TB 60-120 days from the last official TB test date.

## EXHIBITION LIVESTOCK HEALTH REQ.

### SWINE

#### Illinois Swine

##### Identification

1. Swine shall be identified by an official ear tag, tattoo or recognized breed ear notch.
2. Ear notch identification is acceptable for all barrows, crossbred gilts, and breeding swine.

**(Note: Ear notch identification of crossbred swine does not satisfy USDA identification requirements for interstate movement or official testing.)**

##### Brucellosis

**Brucellosis testing is not required for Illinois swine.**

##### Pseudorabies

**Pseudorabies testing is not required for Illinois swine.**

#### Out-of-State Swine

All out-of-state swine are to be accompanied by an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online at:

##### Identification

1. Individually identified by an official ear tag, tattoo or recognized breed ear notch.
2. Ear notch identification is **not** acceptable for crossbred animals.

##### Brucellosis

1. Breeding swine 4 months of age and older shall be negative to an official test for brucellosis within 30 days prior to exhibition unless exempt by one (1) of the following:
  - A. Originate immediately and directly from a validated brucellosis-free herd.
  - B. Originate directly from a validated brucellosis-free state.
2. Swine brucellosis tests for exhibition shall be conducted at a state or federal laboratory.

##### Pseudorabies

1. Swine originating from a Pseudorabies Stage IV or V state are exempt from the pseudorabies testing requirement.
2. Swine originating from a Pseudorabies Stage III state shall be negative to an official test for pseudorabies conducted within thirty (30) days prior to entry or originate immediately and directly from a qualified pseudorabies negative herd.
3. Swine originating from a Pseudorabies Stage I or II state shall be negative to an official test for pseudorabies conducted within the 10 days prior to entry.
4. Barrows and females in market classes must meet the same requirements as breeding swine.

### SHEEP

#### Identification

Individual identification of each animal shall be by an ear tattoo or official metal or plastic tag. A microchip ID is acceptable if the owner provides the reader.

Ear tattoos may be used when a registration certificate, listing the tattoo number, accompanies the animal.

When using ear tags, the tag must indicate the premises ID and state of origin. The tag number must be assigned by a state or APHIS representative and recorded in the Scrapie Record Database.

#### Market Lambs



All market lambs must be slick shorn (show ring ready) before weigh-in so that show lamb fungus can be identified.

## EXHIBITION LIVESTOCK HEALTH REQ.

### Illinois Sheep

1. Sheep originating from a flock that has previously been classified as either an infected or source flock can be exhibited in Illinois upon the completion of an approved flock plan.
2. For any animal born after 1/1/2002, the CVI must include the flock of birth and the flock of origin, if different.

### Out-of-State Sheep

All out-of-state sheep are to be accompanied by an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online at:

## GOATS

### Identification

Individual identification of each animal shall be by an ear tattoo or official metal or plastic tag. A microchip ID is acceptable if the owner provides the reader.

Tattoos may be used when a registration certificate, listing the tattoo number, accompanies the animal.

When using ear tags, the tag must indicate the premises ID and state of origin. The tag number must be assigned by a state or APHIS representative and recorded in the Scrapie Record Database.

Ears should be used for tattooing when possible. If there is no space in the ear, the flank or tail fold may be used.

### Illinois Goats

1. Goats originating from a herd that has previously been classified as either an infected or source herd can be exhibited in Illinois upon the completion of an approved herd plan.
2. For any animal born after 1/1/2002, the CVI must include the flock of birth and the flock of origin, if different.

### Out-of-State Goats

All out-of-state goats are to be accompanied by an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online at:

1. Goats originating from a herd that has previously been classified as either an infected or source herd can be exhibited in Illinois upon the completion of an approved herd plan.
2. Tuberculosis- Goats from areas or states that are not Accredited Bovine Tuberculosis Free, must be accompanied by a CVI indicating that the goats originated from a herd where a complete negative herd test has been conducted within the past twelve (12) months and the individual animals are negative to a tuberculin test conducted within thirty (30) days prior to entry. For any animal born after 1/1/2002, the CVI must include the flock of birth and the flock of origin, if different.

## HORSES, PONIES, MULES AND OTHER EQUIDAE

### Illinois Equine



1. All horses and other Equidae, twelve (12) months of age and older attending an advertised equine event, shall be accompanied by a negative test for equine infectious anemia (EIA) conducted within the last twelve (12) months. A copy of this test shall accompany the animal.
2. AGID (Coggins) or ELISA tests are accepted.

### EXHIBITION LIVESTOCK HEALTH REQ.

3. An advertised equine event means a show, rodeo, sale, auction, exhibition, trail ride, or horse fair that is posted or media promoted.
4. A CVI is not required for Illinois equine.

#### Out-of-State Equine

All out-of-state equines are to be accompanied by an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online at:

1. All horses and other Equidae entering Illinois that are twelve (12) months of age or older, shall be accompanied by a negative test for equine infectious anemia (EIA) conducted within the last twelve (12) months. A copy of this test shall accompany the animal.
2. AGID (Coggins) or ELISA tests are accepted.
3. All horses and other Equidae shall be accompanied by a CVI issued within thirty (30) days prior to entry.

#### POULTRY

1. All entries (except waterfowl, i.e., domesticated fowl that normally swim, such as ducks and geese) in a show or exhibition shall have originated from a U.S. Pullorum-Typhoid Clean or equivalent hatchery or flock OR have a negative pullorum-typhoid test within 90 days prior to exhibition. Exhibitor shall show proper information as to name and address of owner or exhibitor, name and address of the authorized testing agent, date of the testing and the number, breed, and species of those tested.
2. Prior to being used to transport poultry to a show, all crates, boxes, containers, and vehicles shall be thoroughly cleaned and disinfected.
3. Any poultry vaccinations must be performed at least 4 weeks prior to delivery to the show.
4. Upon admission to a show, all entries shall be examined by the official county fair veterinarian or qualified state personnel who shall also receive and examine all certificates necessary for admission of birds to a show. Birds not in show condition will be excused from exhibition and removed from the premises. Any fowl showing signs of illness during the fair will be removed from the exhibition grounds.
5. All out-of-state turkeys must originate from flocks that are officially classified as U.S. Mycoplasma Gallisepticum Clean in accordance with the provisions of the National Poultry Improvement Plan or be negative to a test for Mycoplasma gallisepticum within 30 days prior to entry.
6. A permit is also required for out-of-state poultry. A permit may be obtained by calling (217) 782-4944.

**Please note: These poultry exhibition requirements do not apply to 4-H and FFA 1-day poultry shows where the entries are taken to the show and returned home the same day. However, a permit is required for out-of-state poultry.**

#### CERVIDAE

**(Deer, Elk, Reindeer, Caribou, Moose, Red Deer, and other Related Species)**

##### Identification

All animals shall be individually identified with an approved tag, microchip, or tattoo. Elk are required to have two official/approved unique identifiers.

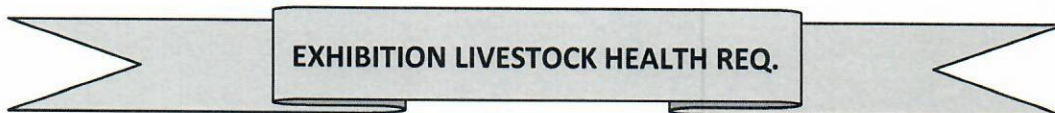
##### Illinois Cervidae

##### Chronic Wasting Disease

For Cervidae changing ownership or moving within the State, the owner must obtain a permit issued by the Department prior to movement and the cervid must originate from a herd that is enrolled in the Certified Monitored Chronic Wasting Disease (CWD) Program or the Contained Monitored Chronic Wasting Disease Program. The permit shall be obtained no more than 72 hours in advance of the movement of the cervids by providing the following information:



- A) Name and complete mailing address of person exhibiting the cervids.
- B) Certified Monitored Chronic Wasting Disease or Contained Monitored Chronic Wasting Disease Herd number.



- C) Name and complete mailing address of location where the animals will be exhibited.
- D) Number of animals and unique identification of the animals.

### **Tuberculosis**

Illinois is an Accredited Tuberculosis-Free State. Tuberculin test is not required for Illinois Cervidae.

### **Out-of-State Cervidae**

#### **Chronic Wasting Disease**

1. All Cervidae entering Illinois must be in compliance with the Illinois Wildlife Code [520 ILCS 5]. For more information, contact the Illinois Department of Natural Resources at 217/782-6384.
2. All Cervidae entering Illinois must be accompanied by a permit from the Department and a Certificate of Veterinary Inspection that:
  - a. has been issued by an accredited veterinarian of the state of origin or a veterinarian in the employ of the United States Department of Agriculture.
  - b. is approved by the Animal Health Official of the state of origin.
  - c. shows that the Cervidae are free from visible evidence of any contagious, infectious, or communicable disease or exposure thereto, do not originate from a CWD endemic area (any county and surrounding counties where CWD has been diagnosed in the past five years).
  - d. shows that the Cervidae are not originating from a herd under quarantine for any contagious, infectious, or communicable disease.
  - e. shows that the animals originate from a herd that has been monitored for at least 5 years under a state approved CWD certification program.
3. A permit number can be obtained by calling (217) 782-4944. Applicant for permit shall furnish the following information to the Department:
  - a. Name and post office mailing address of Illinois destination.
  - b. Name and post office mailing address of the consignor and/or source herds.
  - c. Name and post office mailing address of the herd veterinarian.
  - d. Number and unique identification of Cervidae in shipment.

### **Brucellosis**

Cervidae six (6) months of age and older must have a negative brucellosis card or PCFIA test within sixty (60) days prior to entry.

### **Tuberculosis**

1. Accredited Tuberculosis Free States All Cervidae twelve (12) months of age and over shall be negative to two (2) single cervical tests for bovine TB no less than ninety (90) days apart with the second test conducted within ninety (90) days prior to entry. These animals shall be isolated from all other members of the herd during the testing period unless they originate from an accredited, qualified, or monitored herd.
  - A. Cervidae from an accredited herd may be moved into Illinois without further TB testing provided that a certificate stating that such cervids originated from an accredited herd accompanies them.
  - B. Cervidae originating from qualified or monitored herds may enter with a negative test within ninety (90) days prior to entry and a certificate stating that the animals originate from a monitored herd.
2. Non-Accredited Tuberculosis Free Areas or States (Not TB Free)
  - A. All Cervidae shall originate from a herd where a complete herd test was conducted within the past year.
  - B. The individual animals entering Illinois must be negative to two (2) additional tuberculin tests conducted within 180 and 30 days prior to entry or exhibition.



## EXHIBITION LIVESTOCK HEALTH REQ.

### RATITES

(Ostriches, Emus, Rheas, Cassowaries and Kiwis)

#### Illinois Ratites

There are no requirements governing the movement of ratites within Illinois.

#### Out-of-State Ratites

1. Must be accompanied by a CVI and permit number. Entry permits are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944.
2. Individually identified by leg band or microchip.
3. Negative test for Avian Influenza within 10 days prior to entry.

### PIGEONS

There are no requirements governing the movements of pigeons within or into Illinois.

### RABBITS

There are no requirements governing the movements of rabbits within or into Illinois.

### LLAMAS

There are no requirements governing the movement of llamas within Illinois. A permit and health certificate is required for out-of-state llamas. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at (217) 782-4944. ## PREVENTION RULES

1. It is the policy and the rule of the Kankakee County Fair of Illinois that no animal which is entered for completion in the Fair shall have had administered to it, nor contain any trace residues within it, any substance which is not approved by the Food and Drug Administration (FDA) and/or the United States Department of Agriculture (USDA) for slaughter animals. In addition, no animal entered for competition in the Kankakee County Fair of Illinois will be allowed to be within any withdrawal time relative to the administration of any drug, chemical, or food additive approved by the FDA and or the USDA by the time the animal is officially weighed in by the show.
  - a. It is the sole responsibility of the Exhibitor to ensure that the animal is free of the above prescribed drugs and substances. Extent of knowledge on the part of the Exhibitor regarding the drugs or substance found in an animal is not relevant to any issuer, and it shall not be a defense that a person or persons unknown introduced the proscribed substance into the animal.
  - b. Personnel of the Kankakee County Fair, FDA, USDA/FSIS, Illinois Department of Agriculture and/or Illinois Department of Health reserves the right to take urine, blood, and other body tissue samples from any animal for the purpose of determining whether there is any residue of any of the prescribed substance found within the body of the tested animal. Samples can be taken from the Grand Champion and Reserve Grand Champion of each species following the championship competition. The Exhibitor agrees that he or she will cooperate with the person or persons charged with the responsibility of taking the sample from the animal. Failure to cooperate with testing procedures, or any doing or failing to do any act which will make it unreasonably difficult for the person(s) with the responsibility of taking the sample shall indicate a voluntary withdrawal by the Exhibitor of the animal from competition.

The Exhibitor understands that failure to cooperate fully with representatives of the above-named organizations will result in immediate disqualification of this project and automatic loss of participation privileges in all future fair competitive events.

If the animal passes USDA but fails any FDA testing for the presence of drug(s) or other chemicals, the animal will be condemned by show officials and not allowed for consumption.



## PREVENTION RULES (continued)

- c. All samples shall be taken by a licensed veterinarians and/or other designated persons and tested in an approved Laboratory. Reasonable care shall be taken regarding maintaining the purity and identity of the sample. The only chain of custody required will be that routinely relied upon by veterinarians practicing in and around the Kankakee County area, or as otherwise designated by County Fair Officials.

As samples are taken by a licensed veterinarian, the youth exhibitor, a parent, or guardian, and/or a CEA or AST shall be present to view the procedure. Upon collection of a sample, the youth exhibitor and a parent or guardian or AST or CEA shall provide their signatures in acceptance that the sample was collected from the Exhibitor's animal.

The sample collected will be split into two equal parts with one sample part being taken by a licensed veterinarian to an approved laboratory.

- d. In the event that any animal is disqualified as a result of the violation of any of the rules found within this section, or the animal is voluntarily withdrawn from competition as a result of failure to cooperate with the testing procedures, then the Exhibitor shall immediately return all prizes and/or premiums previously presented but in no event shall it affect the order of finish of any of the other animals competing in the County Fair.
- e. In the event the samples taken from the animal prove to contain a prohibited substance as proscribed above, the Department Chairman and/or Superintendent of the specific specie involved shall undertake to disqualify the animal and impose the sanctions contained herein. The Exhibitor may, within 72 hours of the imposition of the sanctions, appeal in writing the ruling to the Department Chairman to a quorum of the Agriculture/Livestock Committee of the Kankakee County Fair. Failure to appeal in writing the ruling of the Superintendent and/or Department Chairman within 72 hours of disqualification shall result in the disqualification becoming final. In the event a written appeal is lodged, the appeal will be reviewed by the Agriculture/Livestock Committee within a reasonable time frame and the decision of the Agriculture/Livestock Committee shall be final and unappealable.
2. Any other reference which may be found within the rules of the Kankakee County Fair with regard to prohibited substances, drugs and/or testing policy and procedures shall be in addition to the rules set forth within this section and to the extent that they may conflict, the Rules set forth within this section shall control.
  3. By making entry in the Kankakee County Fair livestock competition, the Exhibitor, a parent or both parent(s)/guardian(s), and supervising A.S.T. or C.E.A. agree to abide by this Residue Prevention Policy.
  4. Any dead animals must be removed at owner's expense immediately!
  5. All livestock must be in show flesh condition to exhibit. Determined by Superintendent and Fair Vet on record. No refunds!

### **ALL LIVESTOCK WILL RELEASE ON SUNDAY AT 8:00 P.M. OR WHEN FAIR PRESIDENT ANNOUNCES THEIR RELEASE**

#### **JUNIOR AND OPEN DEPARTMENT**

Exceptions for the following:

1. Open Rabbits release at close of show if not entered in Jr. or 4-H show.
2. Open Gaming Horses only following shows if not entered in Adult, Jr or 4-H show.

**ALL LIVESTOCK MUST BE STALLED BY 7:00 A.M. WEDNESDAY (OPENING DAY OF FAIR)  
UNLESS OTHERWISE NOTED IN THEIR RESPECTIVE DEPARTMENT RULES.  
NO LIVESTOCK WILL BE ACCEPTED PRIOR TO TUESDAY IMMEDIATELY PRECEDING FAIR.**
